BACKGROUND

COFACE Families Europe is a European civil society network representing families (all types, without discrimination), through its 50+ organisations across 23 countries, shaping EU policy and legislation which impacts families: www.coface-eu.org. We monitor a wide range of policies which impact the lives of families and children including worklife balance, disability, education, consumer policy, migration and digitalisation.


This conference will be held online for COFACE members and EU stakeholders on building a caring economy which works for families and children, especially important in light of the COVID-19 pandemic during which families acted as the main social safety net. We will start with a reality-check of the new needs of families of today in the aftermath of the COVID-19 crisis, followed by a discussion on the social and environmental sustainability of the current economic system, and try to trigger actions to sustainably reduce social inequalities, building an economy that works for society.

Taking a holistic economic and societal approach, using the Doughnut economics model as a starting point, we will look at three key dimensions of the economy: **households, the market, and the State**. The discussions and proposals will serve to build key COFACE recommendations for EU and national policy-makers to unlock new thinking for a more social, environmental and economic future.

Doughnut economics



A holistic approach which aims at balancing basic human needs (access to water, food, energy, housing...), with the limitations of our planet (climate change, air pollution, depletion of resources...), putting the economy and the financial sector at the service of society.



What is the place of families?

I. **Earth** which is life-giving, so respect its boundaries

II. **Society** which is foundational, so nurture its connections

III. The **Economy** which is diverse, so support all of its systems

IV. The **Household/Family** which is core, so value its contribution

14.00-15.30	<p>State and local administrations: Policy leadership of public administration in reducing inequalities</p> <p>Inequalities have risen steadily for the last few decades, with a clear acceleration since the 2008 financial crisis, and again following the COVID-19 pandemic. But poverty and inequalities are not just a matter of social justice. They are the bedrock of rising extremism, and a threat to economic and financial stability. In a debt based monetary system, since all money in circulation is debt, anyone accumulating or hoarding too much wealth without spending it into the economy increases the risk of economic actors defaulting on their loans. How can policy makers address inequalities?
