

## EU Policy Webinar on the implementation of the European Care Strategy

9.30-12.00 CET, Tuesday 4th February 2025

## **Background**

Following a proposal of the European Commission for a European Care Strategy, EU Member States adopted two Council Recommendations: one on early childhood education and care, and one on long-term care.<sup>1</sup> The actions taken under both Recommendations are being monitored through different mechanisms and tools.

COFACE advocates for professional care services across the life cycle to help families reconcile their work and family responsibilities.<sup>2</sup> This is essential to help families manage different work-family transitions such as the birth of a child, a major change in employment status of one or both parents, children's transition through the education and later the employment system, special needs of a family member and care given for older family members. The visibility of family carers and their essential support and care to their family members, sometimes with no professional support, is also highlighted through the European Charter for Family Carers.<sup>3</sup>

To support the implementation of the European Care Strategy, COFACE has been monitoring its development closely with the help of an alliance of European civil society and trade union organisations active in the field of care.<sup>4</sup>

## Objectives of the EU policy webinar

This webinar will bring together speakers from the EU institutions, and participants from different fields and backgrounds in order to:

- Discuss tools for monitoring and evaluation of the European Care Strategy implementation;
- Share knowledge from national and EU level in order to strengthen the policy and funding levers to boost implementation.
